Cook/Team Responsibilities

1. Each cooking team will designate one Pit Master and one Alternate.
2. Each team is responsible for maintenance and cleanup of their cooking area. The Pit Master is responsible for the conduct and behavior of the team members and guests. Any team leaving its space in such a condition that will require additional clean-up will be disqualified from participation at future sanctioned events.

Judging turn-In Requirement

1. Greens are allowed in the Judging container. Sauces may be used during cooking process but cannot be in a separate container for entry presentation or judging.
2. Each contestant should submit 6 pieces of product to facilitate adequate judging of the entry presentation or judging.
3. Entries will be turned in at a set time. **NO LATE ENTRIES ACCEPTED!**
4. Blind judging takes place on all food entries. When teams turn in entries, they receive a judging number which is written on top of the entry box.

General Barbecue Cook-off Rules

1. All meat will be provided by LaGrange County Dept. of Parks and Recreation.
2. Meat must not leave the contest area.
3. This is an amateur cooking contest. It is intended to be a fun and competitive event.
4. Only **ONE** team per barbecue pit will be allowed. Where cooking rigs contain two separate pits, two teams may cook (one team per pit).
5. Barbecue, for the purpose of this contest, is defined as raw and uncured meat prepared over a wood, charcoal, pellet, or gas fire.
6. All entries must be prepared in as sanitary a manner as possible. All applicable local health department rules and regulations must be complied with.
7. **NO Vehicles will be allowed in event area after 11:30 a.m.**
Please park in designated area.
8. **NO ALCOHOL IS ALLOWED IN THE PARK!!**
9. **NO FREE SAMPLES before tickets are sold!!!**
